

## **EDITORIAL POLICIES AND PUBLICATION ETHICS**

### **Editorial Policies**

The Proceedings of the 19th Romanian Textiles and Leather Conference is the official publication of the peer-reviewed, accepted and presented papers of the 19th Romanian Textiles and Leather Conference – CORTEP 2024 which is a major international scientific event organized by the Faculty of Industrial Design and Business Management of the Gheorghe Asachi Technical University of Iasi, Romania.

The framework of the conference is supported by the following interdisciplinary topics: Artificial Intelligence applied in textiles, Innovative textile materials and processing, Science and technology of textile machinery, Smart textiles, medical textiles, composites, Digital product development for TCLF industry, Comfort, quality of textiles and sense evaluation, Innovations in textile dyeing and finishing, Recycling, life cycle analysis, sustainability and circularity, Advances in leather processing, Footwear design and technology, New business models and emergent ecosystems, Entrepreneurship and innovation and Engineering education.

CORTEP is organized every two years in Iasi, Romania, by the Faculty of Industrial Design and Business Management of the Gheorghe Asachi Technical University from Iași. This year, [CORTEP 2024](#) will take place from 7 to 9 November 2024 and will combine live presentations (on-site) and virtual presentations (online).

Although no fees are charged for the processing of articles, a registration fee must be paid, which includes access to and participation in all sessions and publication of accepted abstracts in the Book of Abstracts. The registration fee also includes the publication of accepted papers in the Proceedings of the 19th Romanian Textiles and Leather Conference – CORTEP 2024 as open access proceedings by Sciendo (De Gruyter Poland).

For the Proceedings of the 19th Romanian Textiles and Leather Conference, the managing editors will only accept manuscript submissions that conform to the calendar published on the conference website and only if authors comply with the guidelines and mandatory disclosures and adhere to publication ethics.

### **Publication ethics**

Publishing articles in open access publications should be a valuable process for improving knowledge in the field. Therefore, it is important that all parties involved in the publishing process follow recognized best practices and guidelines and adhere to ethical standards. This applies to authors as well as reviewers and the editorial board.

The authors are aware that the peer review process will be conducted via the online [Editorial Manager® for Proceedings](#), provided by Sciendo publisher and operated by the organizers' editorial team.

Invitations and/or assignments of reviewers are made by the editorial team and are addressed to all members of the scientific committee, but also to valuable specialists, experts on

conference topics, from research and academic education. All communication between editors and reviewers is also only possible via the Editorial Manager® system.

The authors are aware that the editorial team participates in the community of users of the [Similarity Check service](#) for comparison purposes to ensure that the published content is original and reliable. If there is a clear suspicion of fraud, the manuscript will be rejected. Fraud means that the peer reviewer and/or the editorial team has determined that parts or the entire text have already been published elsewhere, that there are cases of plagiarism or that there is a suspicion that the data has been falsified.

Please note that authors retain all copyrights to their contributions and should ensure that all individuals who have made a substantial contribution are named as co-authors to take full responsibility for the content of the paper, and that all co-authors have seen and approved the final version of the paper and agree to its publication. All individuals who have made a significant contribution should be listed as co-authors. The authors should cite the publications that have supported the work being reported, as the work of others must always be recognized.

Finally, all authors should disclose in their manuscript any financial support or material conflicts of interest that may influence the results or interpretation of their manuscript.

### **Open Access License**

All manuscripts submitted to the Proceedings of the 19th Romanian Textiles and Leather Conference will be reviewed for originality and scientific merit. Accepted manuscripts will be published as open access proceedings by [Sciendo \(De Gruyter\)](#), with ISBN and DOI numbers for the conference proceedings and the papers.

The main goal of CORTEP 2024 is to publish the peer-reviewed, accepted and presented research articles for the current edition of the conference as Open Access Proceedings, so that all users and interested parties have unrestricted and free access to all content after publication. One of the advantages for the authors of papers published in Open Access is that the tracking of citations is guaranteed, and the papers can be freely downloaded and cited.
